

PRIVACY POLICY (GDPR)

This Privacy Policy defines the procedure for processing and protecting personal data of users of the website www.ftbridge.com (hereinafter — the “Website”) in accordance with the legislation of Ukraine and the **General Data Protection Regulation (EU) 2016/679 (GDPR)**.

1. DATA CONTROLLER

2. CATEGORIES OF DATA SUBJECTS

- Website users (club representatives, coaches, agents, scouts)
- Legal representatives of children (parents, guardians)
- Child athletes (through their legal representatives)

3. PERSONAL DATA PROCESSED

3.1. User data:

- Full name
- Email address, phone number
- Organization and role

3.2. Children’s data:

- Full name
- Date of birth
- Sports performance data and test results
- Photos and videos (subject to consent)

3.3. Technical data:

- IP address
- Cookies
- Device and browser information

4. LEGAL BASIS FOR PROCESSING

Personal data is processed on the following legal grounds:

- consent of the data subject (Art. 6(1)(a) GDPR)

- performance of a contract (Art. 6(1)(b))
- legitimate interest of the Controller (Art. 6(1)(f))

Processing of children’s data is carried out **only with the consent of a legal representative**.

5. PURPOSES OF PROCESSING

- user registration and account management
- creation and maintenance of athlete profiles
- organization and conduct of sports testing
- recording and displaying test results (including video)
- providing access to profiles for clubs, agents, and scouts
- communication with users
- analytics and service improvement

6. PHOTO AND VIDEO PROCESSING

- video recording may take place during testing
- video is used to confirm test results
- processing is carried out **only with explicit consent**
- public use (marketing, social media) — **only with separate consent**

7. DATA ACCESS AND DISCLOSURE

Personal data may be accessible to:

- other registered users (clubs, scouts, agents)
- service providers (hosting, CRM, etc.)

Transfers outside the EU may occur only with appropriate safeguards (e.g., Standard Contractual Clauses).

8. DATA RETENTION

Personal data is stored:

- for the duration of Website use
- until consent is withdrawn
- or as required by applicable law

9. USER RIGHTS (GDPR)

Users have the right to:

- access their personal data
- rectification
- erasure (“right to be forgotten”)
- restriction of processing
- data portability
- object to processing

- withdraw consent
