

TERMS OF SERVICE (USER AGREEMENT)

These Terms of Service (hereinafter — the “Terms”) govern the use of the website (hereinafter — the “Website”).

By using the Website, you confirm that you have read and agree to comply with these Terms.

1. GENERAL PROVISIONS

1.1. The Website is an online platform for:

- creating athlete profiles
- conducting sports testing
- facilitating interaction between athletes and representatives of sports organizations

1.2. The Website owner (hereinafter — the “Administration”) reserves the right to modify these Terms without prior notice.

2. USER CATEGORIES

Users of the Website may include:

- legal representatives of children (parents, guardians)
- representatives of sports organizations (coaches, agents, scouts)

3. REGISTRATION AND ACCOUNT

3.1. The user agrees to provide accurate information.

3.2. The user is responsible for maintaining the confidentiality of their account credentials.

3.3. Sharing account access with third parties is prohibited.

4. ATHLETE PROFILES

4.1. Athlete profiles are created by legal representatives.

4.2. The user guarantees that they have the right to provide and publish information about the child.

4.3. The Administration has the right to add testing results to athlete profiles.

5. VIDEO AND CONTENT

5.1. Video recording may take place during testing.

5.2. Video and other materials are used to confirm test results.

5.3. Video content is published only with appropriate consent.

6. ACCESS TO PROFILES

6.1. Athlete profiles may be accessible to:

- club representatives
- coaches
- agents and scouts

6.2. Users agree to use the obtained information strictly within the functionality of the Website.

7. PROHIBITED ACTIVITIES

Users are prohibited from:

- using other users' data for commercial or other purposes without permission
- copying, distributing, or sharing information with third parties without consent
- providing false information
- violating the rights of other users

8. LIABILITY

8.1. The Administration is not responsible for:

- the accuracy of information provided by users
- decisions made by clubs or scouts
- outcomes of interactions between users

8.2. The Website does not guarantee:

- selection to a club
- any sports-related results

9. ACCOUNT TERMINATION

9.1. The Administration has the right to suspend or delete an account in case of violation of these Terms.

9.2. The user may request deletion of their account.

10. INTELLECTUAL PROPERTY

10.1. All materials on the Website are the property of the Administration or used legally.

10.2. Unauthorized use of materials is prohibited.

11. DISCLAIMER

The Administration does not guarantee uninterrupted or error-free operation.

12. GOVERNING LAW

These Terms are governed by the laws of Ukraine.
